**I should have been a party to my ex-wife's individual bankruptcy (3:19-bk-02693) per the F.R.B.P. and bankruptcy law, because our property was purchased and titled as "Tenancy by the Entirety", while I was clearly named on the deed, and in possession of our home with two lawful tenants/roommates, who also had binding and federally protected, "leasehold property interests" in our home—which could not be terminated or deprived (even if our home entered foreclosure, per the "Protecting Tenants at Foreclosure Act")—though I had access to funds to cure any staged defaults by my ex-wife and her counsel, to prevent foreclosure from being a concern; but I was wrongfully denied notice, any opportunity for an "adversarial proceeding", participation, and "adequate protection" by the bankruptcy court, trustee, judge, and counsel involved. Instead our home was liquidated for roughly half of what we had invested into it, rendering me homeless without one dollar to my benefit.**
