The court does not permit pro se litigants to file directly in CM/ECF. The plaintiff may submit permissible documents containing his written signature to the court's designated pro se email box for electronic filing by the court. 6 Cir. R. 25(b)(2) (A), (d)(3). The email box address is CA06_Pro_Se_Efiling@ca6.uscourts.gov. The court's filing of an emailed pro se document will constitute entry in the docket. Id. at R. 25(e) (1)(B)(ii). He may otherwise continue to submit signed filings in paper. The motion for electronic filing privileges 24 is DENIED. Finally, the plaintiff's motion for public access to all filings 24 is DENIED WITHOUT PREJUDICE. To the extent the plaintiff seeks to unseal documents filed in the district court, he must first move the district court. 6 Cir. R. 11(c)(2). The plaintiff's requests for substantive relief are REFERRED to the ultimate merits panel. (RO) (kc) (Entered: 08/04/2025)
